This concept, as well as the lines constructed through this Journal, is meant to capture and make sense of the movement of the multitude that gradually reveals itself as a power to produce a common idea, challenging the reactionary dominance of biopower towards a new model of living (Lightsey, 2017).

The parameters covered in this edition include practical theoretical development lines such as: intelligence and counterintelligence, history and philosophy, technology and development, administration, finance and economics (ESICI, s.f.). These topics are approached from a perspective eager to contrast perspectives, broaden the fronts of knowledge and strengthen the links of knowledge that expand the horizons of incidence of those thematic areas, which, in the past, were characterized by their exclusive management from military knowledge. In its recent publications, the journal has brought together the participation of civilian and military authors from different professions and lines of research in order to strengthen the analysis and the scientific and academic rigor of the products.
